# 1 PURPOSE, SCOPE, POLICIES/AUTHORITIES

## 1.1 Purpose

---

The purpose of the Emergency Support Function (ESF) 11 Agriculture, Animal Welfare, and Natural Resources Annex is to establish how agriculture, animal welfare, and natural resource activities will be coordinated to meet the needs generated by disasters affecting Wyandotte County.

## 1.2 Scope

---

This ESF Annex provides the mechanism for coordinated local assistance to supplement other emergency support functions and state and federal agencies with overall response authority. This document identifies and organizes the resources available to Wyandotte County to address agriculture and natural resource incidents. ESF 11 addresses five primary areas:

- Household pets and service animals
- Foreign animal disease
- Pest and plant disease
- Food safety coordination, security, and support
- Natural, Cultural, and Historic (NCH) resources preservation and protection

The ESF 11 Annex applies to all participating agencies with assigned incident responsibilities as described in Section 3 Responsibilities. Due to limited local authorities in the areas of food contamination, plant pests, and animal disease, this plan will briefly describe the state and federal roles with an emphasis on potential local roles for supporting a state response.

The ESF 11 resources support state and local authority's efforts to address:

- Command, Control, and Notification including the roles of County and City agencies with incident responsibilities and their working relationships with the volunteer agencies providing incident management services.
- A flexible organizational structure capable of meeting the varied requirements of many incident scenarios with the potential to require activation of the Emergency Operations Center (EOC) and implementation of the Emergency Operations Plan (EOP).
- Control and eradication of an outbreak of a highly contagious or economically devastating animal/zoonotic disease.
- Assurance of food safety and food defense, including prevention, detection, and response of food borne illnesses.

- Provision of nutrition assistance programs.
  - Highly pathogenic exotic plant disease, or economically devastating plant pest infestation.
  - Safety of livestock, and crops against natural or criminal introduction of contaminants.
  - Protection of natural and cultural resources, including wildlife, public land/park management, and protection of historic properties.

Most food and agriculture incidents will not result in a Stafford Act Declaration. Local responders will continue to document activities. U.S. Department of Agriculture (USDA) and U.S. Food and Drug Administration (FDA) have some grant programs that may be implemented.

## 2 CONCEPT OF OPERATIONS

This section provides a narrative description summarizing the Concept of Operations for the following ESF 11 activities: 1) Command, Control, and Notification; 2) Food and Water Supply; 3) Pet Sheltering Operations; 4) Incident Specific Operations; 5) National or State Historical Properties; and 6) Considerations for Access and Functional Needs Populations and Children.

The narrative portions of this section provide summarized overviews for the topics listed above.. Section 3 provides the detailed actions organized by agency detailing their ESF 11 responsibilities.

### 2.1 Command, Control, and Notification

When Emergency Management is notified of an event that requires the activation of the EOC, the Emergency Management Director, in consultation with the County Administrator and emergency management staff, will determine which Emergency Support Functions are required for activation in support of incident operations. If it is determined that ESF 11 will be activated, the Emergency Management Director will contact the designated Coordinating Agency for ESF 11 to report the EOC to attend an initial briefing regarding the situation.

Depending on the complexity or severity of the event, the Emergency Management Director, or designee, may advise the County Administrator that the need exists to declare a local emergency. The Emergency Management Director, or designee, will advise the City Administrators in Bonner Springs and Edwardsville. For more information on a declaration of a local emergency, see the ESF 5 Annex.

The ESF 11 Coordinator is the Wyandotte County Sheriff's Office. The ESF 11 Coordinator is responsible for contacting the primary and support agencies with liaison roles including adjacent counties and the State and briefing them on the situation. The ESF 11 Coordinator will provide departments with the designated methods and timeframes for submitting information and updates to the EOC.

### 2.2 Food and Water Supply

The Kansas Department of Agriculture (KDA) is responsible for conducting inspections and regulating the production and sale of food products in Kansas. When there is a food contamination, Wyandotte County will usually be notified of a problem with a food product through a national release or by the Kansas Department of Health & Environment (KDHE) on the problem or if it relates to a disease investigation.



The safety and security method of the commercial food supply includes the execution of routine food safety inspections and other services to ensure the safety of food products that enter commerce. This includes the inspection and verification of food safety aspects of slaughter and processing plants, products in distribution and retail sites, and import facilities at ports of entry; laboratory analysis of food samples; control of products suspected to be adulterated; plant closures; food borne disease surveillance; and field investigations. These efforts are coordinated at the federal level by U.S. Department of Agriculture's (USDA) Food Safety and Inspection Service (FSIS) and the U.S. Department of Health and Human Services Food and Drug Administration (FDA).

## **2.3 Pet Sheltering Operations**

The care and needs of household pets and service animals prior to, during, and after an incident or disaster are the primary responsibility of their owners. When owners are unable to provide for the care and needs of their animals, then local jurisdictions in Wyandotte County will assist them. Wyandotte County will coordinate with ESF 6 and provide for the rescue, care, shelter, and essential needs of household pets and service animals when owners are unable to provide for their animals in compliance with the Pets Evacuation and Transportation Act of 2006 and Federal Emergency Management Agency (FEMA) Disaster Assistance Policy 9523.19.

American Red Cross (ARC) says service animals are the only animals permitted inside emergency mass care shelters in Wyandotte County. Household pets must be cared for in a separate area of the shelter facility that is isolated from the human component or at a separate shelter facility.

Household pets and service animals may require immediate first aid and emergency medical attention following a natural or man-made disaster. The County has a significant local capability for providing expedient health services to injured response animals, pets and livestock that includes numerous veterinary hospitals and clinics. While Wyandotte County has no zoos or wild animal parks, care for such exotic animals would be available from the Kansas City Zoo, in Kansas City, Missouri. Emergency first aid and medical attention may be required for animals rescued from the disaster area. Those animals may undergo primary decontamination by first responders and a secondary decontamination by certified staff. The nature and extent of each animal's exposure to hazardous materials will guide the administration of secondary decontamination techniques.



Over the entire incident period, household pets and service animals may require non-emergency veterinary attention. Veterinary care will only be administered by qualified staff. Records of individual treatments will be kept, including animal identification information, name of product(s) administered, name of the individual administering the product, and the name of the supervising veterinarian. Some of these medical treatments may include:

- Decontamination – Household pets or service animals that have come in contact flood water or other hazardous materials will undergo decontamination. Primary decontamination may be performed by first responders in the field or outside of the shelter facility. Secondary decontamination may be necessary depending on the type of hazardous material(s) the animal has come in contact with. Secondary decontamination will be performed by a certified responder or qualified veterinarian staff member.
- Triage and First Aid – Emergency care will be prioritized based on the severity of the animal's condition. Only qualified staff may provide first aid to animals. The triage and first aid staff must be able to provide emergency medical care.
- Prevention and Treatment of Transmissible Diseases – Transmissible diseases, including zoonotic diseases, which are shared between animals and people, could pose a risk to humans and animals in a shelter environment. Basic animal management and disease control guidelines will be followed to maintain human and animal health and reduce the risk of disease transmission.
- Isolation and Quarantine – Isolation and quarantine serve to protect human safety and animal health by containing the spread of disease. Rabies isolation areas will be separate from other isolation and quarantine areas.
- Euthanasia – Euthanasia is the act of inducing humane death in an animal. A veterinarian or certified euthanasia technician will make the determination when euthanasia is appropriate and which method will be administered.
- Mortality Management – Appropriate and efficient carcass disposal is required to protect human and animal health, the food supply, and the environment. Kansas Department of Health and Environment will provide direction and oversee this process.

Kansas City, Bonner Springs, and Edwardsville Animal Control officers in Wyandotte County will be capturing and transporting animals in coordination with ESF 6.

Because of the limited resource in Wyandotte County for Animal Welfare response, ESF 11 will reach out to the Kansas Animal Response Team, the Kansas City Veterinary Medical Association (KCVMA), the Kansas Animal Control Officers Association (KACA), and the Kansas Veterinary Medical Association (KVMA) for animal care support.

## 2.4 Incident Specific Operations

---

### 2.4.1 Foreign Animal Disease/Livestock Emergency

Animal health incidents are within the statutory authority and mandate of the Kansas Department of Agriculture (KDA). Wyandotte County will support the state and federal response.

As the lead agency, KDA under the direction of the Animal Health Commissioner in partnership with the USDA will direct all animal disease investigation, surveillance, movement control, diagnostic, biosecurity, animal depopulation, vaccination, carcass disposal, cleaning/disinfection, and recovery activities. Response and recovery activities will be consistent with the established emergency response and recovery protocols of units of local government and with the State of Kansas. This is contrary to the typical hierarchy of authority and responsibility for incident response.

KDA is also responsible for developing disease control plans, procedures, and strategies, controlling the disposition of abandoned, disabled, or dead animals, and managing the consequences from an act of agro-terrorism. If required, KDA will facilitate the relocation of animals from risk areas and provide other technical assistance as required.

### 2.4.2 Stop Movement

An effective response to a highly contagious animal disease outbreak requires immediate action to stop the spread of disease and to contain the pathogen of concern. The Kansas Animal Health Commissioner may issue an order to “Stop Movement” of susceptible animals, agriculture commodities, and related transports as a quarantine and disease containment measure.

A Stop Movement order will require coordination with federal, state, and local government to identify and inspect agricultural products that might contain contagious animals or commodities. The KDA has a process to effectively implement such a plan and it will require significant county resources.

### 2.4.3 Zoonotic Disease

The Wyandotte County Health Department is the lead agency in the human health response for zoonotic diseases and all infectious diseases. They will work closely with the Kansas Department of Health and Environment (KDHE) and the KDA.



#### 2.4.4 Plant Pest and Disease

A plant pest or disease incident may pose a threat to agriculture, horticulture, the economy, or public health. Surveillance and potential threat information will be provided to Wyandotte County through Wyandotte County Kansas State Research and Extension or other state agencies.

Most plant incidents involve the USDA Plant Protection and Quarantine service and involve multiple states. State authority for plant health incidents is vested with the Secretary of the Kansas Department of Agriculture and the State Plant Regulatory Official (SPRO). The SPRO in Kansas is the program manager for the Plant Protection and Weed Control program.

Possible threats and hazards that may lead to a response to a plant health incident may come from:

- United States Department of Agriculture Animal and Plant Health Inspection Service (USDA-APHIS) Plant Select Agent List.
- Watch List of plant pests in Kansas agricultural crops, plantings, and native plants.
- Unknown or emerging pests in Kansas agricultural crops, plantings, and native plants.

In the event ESF 11 is activated for a plant pest or disease emergency, ESF 11 would coordinate with and support state and federal agencies in response efforts.

#### 2.4.5 Food and Water Supply Contamination

The Wyandotte County Health Department is the lead agency in water and food contamination incidents. They will provide personnel, resources, and technical assistance to manage an event involving threats to local food and water supplies. This includes protective actions, community outreach, and public education regarding the potential health risks associated with contaminated food and water.

#### 2.4.6 Radiological Accident with Contamination

The KDHE Radiation Control Program is the lead State agency for operational radiological incidents and will respond to the site of an incident as needed. This effort would be coordinated with ESF 10 and Wyandotte County Emergency Management.



## 2.5 National or State Historical Properties

Wyandotte County will protect the natural, cultural, and historical (NCH) properties resources. This includes providing appropriate response actions to preserve, conserve, rehabilitate, recover, and restore NCH resources. Post-event baseline assessments of damages and providing technical assistance and resources for assessing impacts of response and recovery activities to NCH resources will also be provided. If the incident causes damage to historical sites, Wyandotte County will work with the state and federal government to help ensure appropriate measures are taken to preserve and protect them.

There are various natural, cultural, and historical sites in Wyandotte County. For sport fans, there are two racetrack speedways, a minor league baseball stadium, several golf courses, and a soccer stadium. There are also multiple shopping centers, an outdoor amphitheater, outdoor water park, casinos, county fairgrounds, and a Boy Scout camp all located in Wyandotte County, just to name a few attractions.

Wyandotte County has 51 identified private and public properties that are formally listed as historical sites on the National Historical Registry as of March 2021 (Addendum 7).

The Unified Government Parks and Recreation is responsible for oversight and maintenance of county parks and properties. The Bonner Springs and Edwardsville Parks and Recreation Departments are responsible for oversight and maintenance of parks and properties in their jurisdiction.

## 2.6 Considerations for Access and Functional Needs Populations and Children

---

The Department of Health and Human Services has identified the top 15 languages spoken in households in Kansas. English was identified as the most common language and Spanish as the second most common language spoken in households within Wyandotte County. Some educational materials have been translated into Spanish and, on occasion, other languages. Translation into additional languages will be performed as required.

The Unified Government of Wyandotte County utilizes several vendors for interpretation and translation services. This service is available to all incident response agencies and the Public Information Officers throughout the county. Specific information about how to request and utilize these vendors as well as the languages for which services can be provided is found in ESF 6 Addendum 8 Interpreter and Translator Services.

The local television stations have agreed to provide information in Spanish and other languages as appropriate when they interrupt programming or when text scrolls are used across normal programming. TTY telephone services are available throughout Wyandotte County. In addition, the Kansas State School for the Blind can assist with Braille interpretation.



### 3 RESPONSIBILITIES

This section describes responsibilities and actions designated to coordinating, primary, and support agencies. Actions are grouped into phases of emergency management: Preparedness, Response, Recovery, and Mitigation.
